**Participants General Terms & Conditions**

**Operator Agreement**

This agreement sets forth the terms and conditions pursuant to which Trans American International Development (Shanghai) Ltd. and Larson WorldWide, Inc. (hereafter referred to as "Operators", in return for payment by the conference participant of the amount specified as the trip price, agrees to provide the services and features as described in the program agenda. Please read this agreement carefully before sending any money.

### **Reservations and Method of Payment**

The deposit for the tour is US\$1500.00 per person. The tour operators will accept payment by check made out to Larson WorldWide-Tour or credit card (MasterCard, Visa or American Express). The deposit must be received by July 30<sup>th</sup> to assure room on the tour. The balance of US\$ 1800.00 is due no later than September 1<sup>st</sup>.

Upon receipt of your deposit, you will receive a letter of confirmation and travel insurance information. Please note that tour participation is limited to 30 participants or as space allows.

All international checks must be payable through a U. S. bank or clearinghouse and made payable to Larson WorldWide-Tour . All payments must clear the tour participants bank account for the reservation to be considered valid. Failure to comply with the payment policy as set forth above will result in automatic cancelation of the reservation.

### **Rates**

Prices quoted are based on fares in effect as of the time of printing and are subject to change prior to departure. Prices could increase in the event of significant airline or hotel charges or taxes. Participants will be notified of any such price increases at least 45 days prior to departure.

### **Cancellations**

You are entitled to a full refund if the tour is cancelled by the operators. Written or email cancellation received by July 30<sup>th</sup> to Larson Worldwide: full deposit refund less a US\$ 300.00 administration fee, July 31- September 1 full refund of any recoverable land and air costs, less a US\$ 1000.00 per person cancellation charge (includes administrative fee), Written or email cancellation between September 2 and October 1<sup>st</sup> results in the forfeit of majority of funds' including a US\$ 1000.00 per person cancellation fee (includes administrative fee). Cancellation in this time period could involve a loss of as much as 100% of land costs per person. Cancellations received after October 1<sup>st</sup>: no refund.

Ticketed passengers must return unused tickets and any other negotiable vouchers for an applicable refund to be processed. No refund will be given for any passenger who, may for any reason, does not arrive for airline or vehicle departure. No refund will be made for features that a passenger opts not to use. Once travel begins, any changes made by the passenger is the responsibility of the passenger. Cancellation/changes caused by accident or illness to a passenger does not constitute waiver of applicable fees. Refunds will be processed within 90 days of receipt of cancellation notice.

### **Travel Insurance**

Because cancellation policies are strictly enforced, we strongly recommend for you protection that you purchase trip cancellation insurance. Travel Insurance is also highly recommended in order to protect participants who must cancel or interrupt their trip due to illness or injury.

### **Itinerary or Program Modifications**

While every effort will be made to our tour itinerary as planned, the operators reserve the right to modify the itinerary or programs at their discretion, as warranted by circumstances at the time of the tour, including the right to substitute hotels of similar quality. In the event of any changes, the operators will work to substitute programs of comparable value.

### **Transportation**

Participants are responsible for booking their flights from their home cities to Shanghai, China and return passage. Once an application has been received by the operators, Suggested group flight information will be provided for travel from Los Angeles to Shanghai so as many of the tour participants can travel from the USA together to Shanghai.

### **Responsibility Disclaimer**

The tour operators act only as an agent for the participants with respect to travel services, and shall not be responsible for changes in flight times, fare changes, dishonor of airline, hotel or other reservations, injury, damage, loss of baggage, accidents or for the acts or defaults of any person or entity in conveying participants or in carrying out other arrangements of the tour
